In reference to Notification No. INY/S/P/13/23, INY is inviting individuals to be a District Coordinator and henceforth the detailed process of selection / responsibilities of a District Coordinator is underlined below.

SELECTION OF DISTRICT COORDINATORS

- 1. Individuals willing to be a district coordinator shall apply at <u>iny.climefy.in</u>.
- 2. The individuals will undergo a Personal Interaction with a Board Comprising of Members from the State Committee, Executive Body and General Volunteers.
- 3. Based on the Board's internal judgement, applicants will be selected as District Coordinator of their respective district. If more than one applicant applies for being the District Coordinator of a particular district, the Board will select one of the applicants as the District Coordinator and others will be selected as the Volunteers. However, there is a flexibility of changing the conditions if and when situation demands.
- 4. An applicant to apply for being a District Coordinator of a particular district must reside in that respective district and shall reside for the next 2 years from the date of application for being the District Coordinator.
- 5. The application must be put online and no offline applications are entertained.
- 6. Individual applying for being the District Coordinator must have passed 12th Standard or equivalent and not more than 60 years of age.
- 7. Individual applying for being the District Coordinator must not be holding any position in any Political Organisations or affiliated organisations of any Parties or any other Organisations.
- 8. Applicants must have a basic and general knowledge of the district.

RESPONSIBILITIES AND POWERS OF THE DISTRICT COORDINATORS

- District Coordinators will lead the respective district Unit.
- District Coordinators will function independently but in due consultation of the Core Committee.
- They will have complete authority to recruit volunteers of their respective unit.
- District Coordinators shall be responsible for all events in that district and internal organisation of the unit.

- District Coordinators can register their units with Nehru Yuva Kendra.
- District Coordinators must abide by INY Constitution and shall report to the State Committee about all activities.
- Meetings with any person from the District Administration shall be done with prior information of the State Committee.
- District Coordinators can collect funds for events independently but with prior information of the State Committee.
- In cases of certain discrepancies, the verdict of State Committee is final and bounding for the District Coordinator.

CRITERIA OF FORMATION UNITS AS PER ARTICLE 7, PART IV, INY Constitution

- 1. A unit can be formed only if the unit contains minimum of 5 individuals.
- 2. Any events undertaken by the unit must be done with due approval from state committee
- 3. No funds will be collected by any unit from no one in the name of INY without prior information/ permission
- 4. Meetings with any district/state government official shall be done with due approval/ information from INY state committee.
- 5. Units must abide by INY constitution and INY state administration.
